

## **Effective April 20, 2016**

MA Center currently safeguards the privacy of providers of Personal Information (as the term is defined below) in accordance with this Privacy Policy with respect to this website [list.ammagroups.org](http://list.ammagroups.org) and under sub-domains (the “Website”). Please read the following policy to understand the rules and procedures followed by MA Center in handling Personal information provided to us whether over the Internet or otherwise.

### **What information does MA Center collect?**

MA Center collects the Personal information only from persons who contact us or otherwise provide the information to us, or that is collected by various affiliated Amma organizations (satsangs and centers). As you navigate the Website, we may also collect information through the use of commonly-used information-gathering tools, such as cookies and web beacons. “Personal Information” means your name, telephone number, spiritual name, email address, postal address provided by you to MA Center whether through the Internet, mobile applications or any other form of communication.

### **How MA Center uses the Personal Information**

We use your Personal information to respond to and fulfill your requests for products and services in connection with Amma, including, but not limited to:

1. Sending information about the activities relating to Amma, Amma’s disciples, satsangs, events and updates in the Amma community, MA Center and our projects. For example, MA Center may use information you provide to contact you to further discuss your interest in the services and to send you information regarding MA Center, its affiliates, and its partners, such as information about promotions or events.
2. Sending e-newsletters relating to the above specified list.

### **When we disclose Personal Information to others**

1. MA Center does exchange Personal information with other affiliated Amma organizations (satsangs and centers) in the U.S. so that they can contact people on the mailing list about Amma programs and events.
2. Personal Information provided by you to MA Center is never shared with any non-affiliated commercial organizations and is never sold, rented or given to unrelated third parties.
3. MA Center will disclose Personal Information if required by law or if MA Center reasonably believes that use or disclosure is necessary to protect MA Center’s rights and/or to comply with a judicial proceeding, court order, or legal process.

### **Right to control and correct Personal information**
